The Department of Financial Services is seeking applicants to fill the position for a Director of Cybersecurity Supervision. The incumbent of this position will work directly with the agency's Executive Deputy Superintendent for the Cybersecurity Division and other high level executive staff. The incumbent of this position will serve in this leadership role which is primarily focused on cybersecurity policy and guidance. Responsibilities will include overseeing the examinations of regulated entities, as well as reviewing and drafting memoranda of law, regulatory guidance, and new regulatory and legislative proposals. Responsibilities will also include providing updates to the Superintendent and other senior staff, and may include assisting with cybersecurity enforcement matters. The incumbent will be expected to oversee the work of more junior attorneys and staff.

Preferred Qualifications:

Formal qualifications are not filed for this position. However, the following may be considered minimally acceptable: Admission to the New York State Bar and at least four years' experience in the practice of law involving one or more of the following: counseling, regulatory, or investigatory/enforcement work. Experience with incident response, cybersecurity, and/or data privacy is preferred.
